Report on Business

On April 27, 2021 the Issuer announced that its wholly owned subsidiary Harrys International Manufacturing Inc., together with its manufacturing partner, has now received the necessary authorizations to order Excise stamps needed to begin cigarette production and distribution in the Provinces of Alberta and Saskatchewan.

On April 30th the Issuer provided the Manitoba ministry of Finance with a \$25,000 security deposit as final requirement for issuance of its wholesale Tobacco License in the Province of Manitoba.

2. Provide a general overview and discussion of the activities of management.

Management is finalizing Health Canada packaging requirements with its manufacturing partner in preparation of starting production for cigarette's destined for sale in Alberta and Saskatchewan.

In April management provided the BC Ministry of Finance with the \$200,000 Letter of Credit documentation issued by its Financial Institution as part of the final requirement for issuance of its tobacco wholesale license for the Province of British Columbia. With final requirements completed at end of April, management anticipates its wholesale license to be issued from both the province of BC and Manitoba in the near future.

During the month of April management submitted tobacco wholesale license applications in the Provinces of Newfoundland Labrador and Nova Scotia.

Many government offices remain closed or operate under limited hours due to Covid-19, making it difficult to contact or communicate with staff. The Issuer has been advised that some government department personnel are working from home and to expect delays as a result of Covid-19.

In December 2019, a strain of novel coronavirus (now commonly known as "COVID-19") was reported to have surfaced in Wuhan, China. COVID-19 has since spread rapidly throughout many countries, and, on March 11, 2020, the World Health Organization declared COVID-19 to be a pandemic. In an effort to contain and mitigate the spread of COVID-19, many countries, including the United States and Canada, have imposed unprecedented restrictions on travel, and there have been business closures and a substantial reduction in economic activity in countries that have had significant outbreaks of COVID-19.

At this time the Company remains open for business, however significant uncertainty remains as to the potential impact of the COVID-19 pandemic on our operations, and on the global economy as a whole. Government-imposed restrictions on travel and other "social-distancing" measures on assembly of groups of persons, have the potential to disrupt supply chains for parts and sales channels for our products, including delays in obtaining any necessary regulatory and government approvals.

It is currently not possible to predict how long the pandemic will last or the time that it will take for economic activity to return to prior levels. We will continue to monitor the COVID-19 situation closely and intend to follow health and safety guidelines as they evolve.
