On November 2nd, the issuer terminated the CMO.

On November 30th, the issuer gave notice to a Marketing & Design Specialist, Senior Angular Developer, Senior Architect and three Full Stack Developers.

These terminations are not anticipated to have a material impact on the Issuer's operations, ability to service its clients or execute on its product development pipeline.
