NORTHBUD owns and operates, through its Canadian subsidiary, GrowPros MMP Inc., a licensed cannabis facility in Quebec, Canada. The Company built and owns a state-of-the-art purpose-built cannabis production facility

located on 135 acres of agricultural land in Low, Quebec, Canada through its subsidiary 9366-4027 Quebec Inc. The Low, Quebec facility currently has 20,500sq. ft. of licensed indoor cultivation space and an additional 1,000,000 sq. ft. of licensed outdoor cultivation space.

Quebec Cultivation Update:

During the month of February 2021, the company received results from crops harvested in January. Based on test results the company decided to commence production of its Blue Iguana Strain for commercialization.
