*On the 21<sup>st</sup> December 2018 GreenBank Capital received a loan of \$250,000 from its majority owner, Mrs. Zara Wettreich. The loan is payable on demand and has a zero percent interest rate. The monies will facilitate the Company completing projects relating to its various portfolio companies and to supplement operating capital.*

*GreenBank originally announced on November 27<sup>th</sup> a delay in filing its Financial Statements and explained that it expected to file the 2018 Annual Financial Statements on or before December 15, 2018. It now expects to file the 2018 Annual Financial Statements before the end of January.*

*On 5<sup>th</sup> December 2018, GreenBank Capital was notified by the Ontario Securities Commission that the MRCO which had been filed had not been filed 2 weeks prior to the due date of filing the 2018 Annual Financial Statements, and we were therefore in default of CSE requirements. We were further informed that effective immediately, GreenBank Capital would be suspended pursuant to CSE Policy 3. The suspension is considered a Regulatory Halt as defined in National Instrument 23-101 Trading Rules. A cease trade order has been issued by the Ontario Securities Commission. Management is working with the Auditors to complete the due consolidated financial statements, to be reinstated for trading on the CSE*

*Management completed the reorganization of the Boards of all portfolio companies which had been necessary as a result of the passing of Daniel Wettreich, the Founder Chairman and CEO, and re-established signature authorities for all portfolio companies.*
