#### **Report on Business**

**The Issuer generates revenues from the sales and distribution of value priced, premium quality, 100% natural tobacco cigarettes. The Issuer continues to focus its efforts on obtaining the necessary government license approvals and excise stamp registrations in provincial regions to facilitate tobacco cigarette sales in Canada.**

**Health Canada announced that it will be introducing new plain packaging regulations in 2020 on Tobacco products sold in Canada. The new regulations prohibit brand colors, graphics and logos on packages, making all packaging identical other than the product name, which has to be displayed in identical font. In addition, Canadian cigarette sales continue to trend towards deep discount pricing brands. Harrys management saw this as an opportune time to enter the Canadian market.**

2. Provide a general overview and discussion of the activities of management.

**During the month of January the Issuer communicated and responded to questions from Provincial Tax Authorities in the provinces of BC, Manitoba, Ontario and Quebec where it currently has wholesale tobacco license applications under review for approval to transact business. As previously announced the Issuer has currently received Tobacco Wholesale License approvals in the provinces of Alberta and Saskatchewan.**

**The Issuer's exclusive manufacturer is federally licensed and has both a provincial tobacco license permit to transact business in Quebec, as well as registration with the CRA Quebec stamping regime to manufacture and purchase the necessary excise stamps for sales and distribution of Harrys brand tobacco cigarettes in Quebec.**

**The Issuer is working with its exclusive manufacturer to update and amend the manufacturer's registration with the CRA stamping regime to facilitate the purchase of excise stamps for sales and distribution of Harrys brand cigarettes in BC, Alberta, Saskatchewan and Manitoba, where the Issuer currently has license approvals to transact business or applications pending.**

**Many government offices remain closed or operate under limited hours due to Covid-19, making it difficult to contact or communicate with staff. The Issuer has been advised government department personnel are working from home but to expect delays as a result of**

**Covid-19. The Company will continue to provide corporate updates as further tobacco license applications or stamp registration approvals are obtained.**

**The issuer has developed a HARRYS brand premium Canadian blend cigarette product that is value priced for sale and distribution in Canada. Further to section 2 above the Issuer will commence sales and distribution of its HARRYS Canadian brand cigarettes to provinces once both the appropriate provincial government approvals and tax stamp regime registrations have been received by its manufacturer.**

**In December 2019, a strain of novel coronavirus (now commonly known as "COVID-19") was reported to have surfaced in Wuhan, China. COVID-19 has since spread rapidly throughout many countries, and, on March 11, 2020, the World Health Organization declared COVID-19 to be a pandemic. In an effort to contain and mitigate the spread of COVID-19, many countries, including the United States and Canada, have imposed unprecedented restrictions on travel, and there have been business closures and a substantial reduction in economic activity in countries that have had significant outbreaks of COVID-19.**

**At this time the Company remains open for business, however significant uncertainty remains as to the potential impact of the COVID-19 pandemic on our operations, and on the global economy as a whole. Government-imposed restrictions on travel and other "social-distancing" measures on assembly of groups of persons, have the potential to disrupt supply chains for parts and sales channels for our products, including delays in obtaining any necessary regulatory and government approvals.**

**It is currently not possible to predict how long the pandemic will last or the time that it will take for economic activity to return to prior levels. We will continue to monitor the COVID-19 situation closely and intend to follow health and safety guidelines as they evolve.**
