The Issuer is engaged in acquisition, exploration and development of mineral property assets in Canada. The Issuer's objective is to locate and develop economic precious and base metal properties of merit and to conduct its exploration program on its sole

property, the Wing Pond Property. The Wing Pond Property is located roughly 40 km east-northeast of Gander, Newfoundland, Canada, in the Central Newfoundland.

Management focused on results of programs on the Wing Pond Project, PEG lithium project and Tom Joe project to determine the next phase of exploration programs, as well as acquisition opportunities.
