The Issuer is developing and has made certain announcements with respect to a five year technology roadmap and strategic vision which includes blockchain transaction processing using M/API, bulk volume contracts, dynamic rates, and client tiering; managed services for blockchain computer

hosting, hash contracts and TAAL Pool – a public blockchain computing pool; services and pilot projects stemming from the filed patent application related to the method and device for generating random numbers; blockchain services; and Internet of Things (IoT) agents and services.

The common shares of the Issuer began trading on the OTCQX® tier of the OTC market in the US and completed a symbol change to TAALF on that exchange.

A subsidiary of the Issuer engaged a new employee in the role of 'Chief Compliance Officer' with an initial start date of September 28, 2020.

On June 12, 2020, the Issuer disclosed that the Hosting Provider had sought to include the Company in its arbitration with Tansley Equipment Limited ("Tansley") and another entity in relation to the termination of hosting contracts; and had alleged that the Issuer, and several other entities, were jointly and severally liable with Tansley for a claim of US\$3.9 million. The Issuer successfully disputed that claim, on the basis that it was not within the jurisdiction of the arbitration proceedings and was not party to the agreements that gave rise to the arbitration proceedings. The decision of the arbitration tribunal is final and non-appealable.

On July 6, 2020 the Issuer disclosed that in connection with a dispute between the sellers of blockchain computing equipment purchased by the Issuer and their former hosting provider (the "Hosting Provider"), an arbitration tribunal had unanimously determined the Issue was not properly a party to the proceedings.

The changes in the market surrounding the regulation of digital assets has the potential to create additional costs of compliance for our business. Macroeconomically, the COVID-19 outbreak has affected and will likely continue to affect our business as the practical logistics of cross border shipping and transport of equipment has been significantly impacted, which presents a material disruption to our strategic build out schedule for infrastructure.

The use of Bitcoin SV, Bitcoin or other digital assets to, among other things, buy and sell goods and services, record information and complete other transactions, is part of a new and rapidly evolving industry that employs digital assets based upon a computer generated mathematical and/or digital asset protocol.

The growth of this industry in general, and the adoption and use of Bitcoin SV blockchain as a medium for commercial data interchange in particular, is subject to a high degree of uncertainty, and the slowing or stopping of the development or acceptance of developing protocols may adversely affect the demand for Bitcoin SV and the value added services developed by the Issuer.

Factors affecting further development of the industry include, but are not limited to, continued worldwide growth in the adoption and use of digital assets, governmental and quasi-governmental regulation of digital assets and their use, or restrictions on or regulation of access to and operation of the network or similar digital asset systems, changes in consumer demographics and public tastes and preferences, the availability and popularity of other forms or methods of buying and selling goods and services and general economic conditions and the regulatory environment relating to digital assets, each of which is beyond the reasonable control of the Issuer and could materially adversely affect its business.
