NORTHBUD owns and operates, through its Canadian subsidiary, GrowPros MMP Inc., a licensed cannabis facility in Quebec, Canada. The Company built and owns a state-of-the-art purpose-built cannabis production facility

located on 135 acres of agricultural land in Low, Quebec, Canada. The Low, Quebec facility currently has 24,500 sq. ft. of licensed indoor cultivation space; the Company has recently submitted its licence amendment application to Health Canada to add an additional 1,000,000 sq. ft. of outdoor cultivation space.

Quebec Cultivation Update:

On July 17, 2020, the Company received an amendment to its cultivation license to allow for outdoor cultivation.

On July 24, 2020, the Company began planting a crop of 2500 mature plants received through an arrangement with another licensed producer.
