Aether is pleased to report the following activity for the month of March:

In March Aether was primarily focussed on the preparation of many samples for evaluation by potential partners. Synthesis is well underway and initial quality checks are excellent. Other activities involved evaluating the new compound Aether synthesized at the end of February. The catalyst material shows some of the sought-after attributes but is not as universal as hoped. Study and or modification of the compound may lead to valuable insights or new materials in the future.

The company shipped it's second batch of catalyst to our JDA partner and is awaiting its processing and return for testing; in anticipation of that testing, the test reactor has been undergoing preparative maintenance and Aether has been adding to the baseline of relevant chemistries.

Aether finalized the MTA with the Asian tier-one supplier and expects to ship parts for initial testing in April.

The Company's meetings with the small motors manufacturer we fruitful; we now know that small motors manufacturers are fully anticipating a legislated requirement for catalytic treatment of emissions, and that the only solution currently available to them are precious metal catalysts. We've been informed of the anticipated range of allowable emissions, and believe that we can provide a solution (just our NOx catalyst utilized in USMEAP alone gets us into the expected range).

Finally, at the end of the month, the company executed an NDA & MTA with one of the largest aftermarket catalytic converter manufacturers in North America (due to delayed approvals, it wasn't announced until April and this monthly report was in turn delayed). They will be testing both our automotive and small motors catalysts in standardized on-vehicle tests.
