Report on Business

Aether is pleased to report the following activity for the month of March:

In March, Aether continued efforts along with the Tier 1 manufacturer to gather market intelligence to support the desired collaborative development projects.

In March the team was focussed on material improvements to our synthesis device and re-establishing stable operation of our SORE lab-scale reactor. SORE full-scale equipment was delayed longer than expected and shipped at the end of the month. Assembly and preparations are underway to commission the full-scale test bed. As reported last month, the team had established a counter measure to the degradation phenomenon. Subsequently, this month, the team was able to confirm and eliminate the source of the problem. Once done, Aether's SORE team confirmed that the changes will not impact results and then proceeded to reconfirm the test data baseline. Beyond that, the SORE team is working on qualifying and quantifying catalyst behaviors across an expanded operational window and maximizing the combination of HC and NO conversion in the SORE catalyst system.

Last month Aether reported large gains towards producing lab relevant quantities from our new synthetic equipment. Midway through March Aether received analysis of that product material which revealed substantially compromised morphology and low surface area. These results fit with the small sample we tested that was effectively inactive. The team has reverted to the last process that generated good morphology and have now designed and identified a series of changes and improvements that will support our target quantities and qualities. These improvements will be implemented in stages and support longer, more stable operation leading to easier lab-scale output. The stages are environmental control, electronic stability plus controls and monitoring, and finally, high throughput modifications. This will enable the team to get back to focussing on innovating and improving on the chemistry.
