Report on Business

The Issuer continued to focus on its core business of developing and selling CBD products online in the United States and Europe. The Issuer has cancelled the acquisition of Franchise Cannabis Corp. ("FCC"), previously announced in January.

On May 13, 2021 and May 28, 2021, the Issuer provided its bi-weekly update update on the status of the management cease trade order granted on May 3, 2021 (the "MCTO") by its principal regulator, the British Columbia Securities Commission under National Policy 12-203 – Management Cease Trade Orders ("NP 12-203"), following the Issuer's announcement on April 29, 2021 (the "Default Announcement") that it was unable to file its audited annual financial statements for the year ended December 31, 2020, and acIssuering management's discussion and analysis, annual information form and related certifications (collectively, the "Documents") on or before April 30, 2021, as required under applicable securities laws. The MCTO does not affect the ability of investors who are not insiders to trade in the securities of the Issuer.

While the Issuer's annual audit is ongoing, due to the Issuer's auditors requiring additional time to complete their audit, the Issuer now expects to file the Documents on or before June 14, 2021. The Issuer continues to work closely with its auditor to remedy the default status and file the Documents as soon as possible.

The Issuer reports that: (i) there are no changes to the information contained in the bi-weekly status updated dated May 13, 2021 and May 28, 2021 that would reasonably be expected to be material to an investor; (ii) the Issuer is satisfying and confirms that it intends to continue to satisfy the provisions of the alternative information guidelines under NP 12-203 and issue bi-weekly default status reports for so long as the delay in filing the Documents is continuing, each of which will be issued in the form of a press release; (iii) there has not been any other specified default by the Issuer under NP 12-203, and, except as set forth below, no such other default is anticipated; (iv) the Issuer is not subject to any insolvency proceedings; and (v) there is no material information concerning the affairs of the Issuer that has not been generally disclosed.

In connection with the delay in filing the Documents, the Issuer anticipates that it will not be able to complete and file its interim financial statements, CEO and CFO certifications, and management's discussion and analysis (the "Interim Filings") for the three-month period ended March 31, 2021, by the filing deadline of May 31, 2021. The Issuer anticipates filing the Interim Filings after filing the Documents. The MCTO will stay in effect until the

Documents and, if applicable, the Interim Filings are completed, and the Issuer will continue to issue bi-weekly default status reports as required.

During the month-ended May 2021, the Issuer's principal activities consisted of general administrative and business management.

The Issuer continues to work closely with its auditor to remedy the default status and file the financial documents on or before June 14, 2021.

The Issuer did not launch any new products or services in May.
