*During November 2020, the Issuer continued to operate in the ordinary course and is actively managing and focusing on the activities discussed in Item 1. Consistent with all businesses, the COVID-19 outbreak has required modification to certain of the Issuer's operating practices; however the impact, to date, has been reduced as the Issuer's business has been identified as an exempt business where its operations are located. Certain of the Issuer's customers have altered operating procedures as a result of the outbreak and the impact of such changes is being monitored by the Issuer. The Issuer may face disruptions to operations and supply chain delays as a result of the COVID-19 outbreak. There can be no assurance that the Issuer's personnel will not be impacted by COVID-19 and ultimately that the Issuer would see its workforce productivity reduced or incur increased medical costs/insurance premiums as a result of these health risks. The Issuer will continue to monitor the situation and take measures that alter its business operations as may be required by federal, state or local authorities and/or that the Issuer deems are in the best interests of its employees, customers, partners, suppliers, shareholders and stakeholders.*
