*TXS Venture Exchange Application: On November 11, 2020, the Issuer announced that it applied to list its shares on the TSX Venture Exchange.*

*Exploration Update: On November 12, 2020, the Issuer reported that it has launched a Preliminary Economic Assessment ("PEA"), due in Q1-2021, to assess the potential to quickly restart production for minimal capital expenditure at its Bunker Hill Mine located in Idaho's Silver Valley, USA. The PEA will be based on the resource published on September 28, 2020.*

*Option Agreement: On November 23, 2020, the Issuer announced that it has successfully renegotiated its option agreement for the purchase of a 100% interest in the saleable assets at the Bunker Hill Mine complex from Placer Mining Corporation (the "Lessor"). Under the new terms, the purchase price has been decreased by 30% from USD11.0 million to USD7.7 million.*
