Argo Gold is actively exploring and advancing its flagship Uchi Gold Project in the Red Lake District. The consolidated 22 square kilometre exploration project includes Woco, Northgate, additional mineral claims staked along the southwest extension of the Uchi Gold Corridor, and the Geisler patents.

Argo Gold completed a detailed biogeochemical survey covering a 600 metre wide swath along 5 kilometres of the Uchi Break Gold Corridor and press released the results of the survey on Monday, October 28, 2019.

Argo Gold also mapped and sampled the RainGold / Milberry / HST showings located in the northwest area of the Uchi Gold Project and press released the results on Wednesday, November 6, 2019.
