Report on Business

1. Provide a general overview and discussion of the development of the Issuer's business and operations over the previous month. Where the Issuer was inactive disclose this fact.

The Issuer generates revenues from the sales and distribution of value priced, premium quality, organically grown tobacco cigarettes. The Issuer is currently focusing its efforts on obtaining the necessary government license approvals and stamp registration in provincial regions to facilitate tobacco cigarette sales in Canada.

Last year Health Canada announced that it will be introducing new plain packaging regulations in 2020 on Tobacco products sold in Canada. The new regulations prohibit brand colors, graphics and logos on packages, making all packaging identical other than the product name, which has to be displayed in identical font. Harrys management saw this as an opportune time to enter the Canadian market and started inquiring into all the necessary requirements, guidelines, steps and whether it could even gain access to the distributors and retail markets in Canada to generate sales. The North American market is predominantly dominated by the big three or four tobacco companies, and up until recently was difficult to introduce a new cigarette brand in the Canadian market.

2. Provide a general overview and discussion of the activities of management.

During the month of September the Issuer announced it received its Province of Alberta Tobacco License from the Alberta Treasury Board & Finance for wholesale distribution and sales of tobacco cigarettes in the province of Alberta. The Issuer is waiting on registration approval with the Pacific region tax regime, once received it can proceed with ordering product manufacturing, followed by distribution of HARRYS brand cigarettes destined for sale in Alberta.

In September the Issuer announced it has submitted three additional license applications for approval to sell wholesale tobacco cigarette products in the Provinces of Saskatchewan, Manitoba and Ontario. As well as an application that is currently in the final review stages with the BC Ministry of Finance, for approval to sell tobacco cigarette products in British Columbia and operate a distribution warehouse facility in Abbotsford, BC.

Many government offices remain closed due to Covid-19 making it difficult to contact or communicate with staff. The Issuer has been advised government department personnel are working from home but to expect delays. While the Issuer cannot guarantee if or when it will

ultimately receive approval to transact business in any of the above noted Provinces, it is optimistic that approval will be obtained in the foreseeable future.

The issuer has developed a HARRYS branded premium Canadian blend cigarette product for sale and distribution in Canada. As noted in section 2 above the Issuer will commence sales and distribution of its Harrys Canadian brand cigarettes to provinces where all appropriate government approvals and tax regime registrations have been received.

In December 2019, a strain of novel coronavirus (now commonly known as "COVID-19") was reported to have surfaced in Wuhan, China. COVID-19 has since spread rapidly throughout many countries, and, on March 11, 2020, the World Health Organization declared COVID-19 to be a pandemic. In an effort to contain and mitigate the spread of COVID-19, many countries, including the United States and Canada, have imposed unprecedented restrictions on travel, and there have been business closures and a substantial reduction in economic activity in countries that have had significant outbreaks of COVID-19.

At this time the Company remains open for business, however significant uncertainty remains as to the potential impact of the COVID-19 pandemic on our operations, and on the global economy as a whole. Government-imposed restrictions on travel and other "social-distancing" measures such restrictions on assembly of groups of persons, have the potential to disrupt supply chains for parts and sales channels for our products, and may result in labor shortages.

It is currently not possible to predict how long the pandemic will last or the time that it will take for economic activity to return to prior levels. We will continue to monitor the COVID-19 situation closely, and intend to follow health and safety guidelines as they evolve.
