Trading of the Issuer's securities were halted in December pending the approval of the merger plan between the company and its 46% controlling shareholder, BioHarvest Ltd. We have maintained continuous contact with the CSE to provide all the requested documents required to properly conduct their due diligence. The Company, as announced on December 13, 2019, has a current Private Placement open, to issue up to 35,200,000 common shares at \$0.15 per share.

Management continues to look for manufacturing partners to leverage its Biofarming technology and simultaneously support the next phase of the Company, the development of

a facility with production capacity.
