On March 3, 2020, the Issuer filed a claim for declaratory relief, among other things, in the Superior Court of Suffolk County, Massachusetts, requesting the Court declare the Issuer validly exercised its option to acquire In Good Health, Inc. ("IGH") and instruct IGH to comply with the Issuer's diligence requests and ultimately execute a merger agreement with the Issuer. The dispute regarding whether the Issuer properly exercised its option dated October 31, 2018, as amended, to acquire IGH arose after the Issuer delivered a notice of exercise to IGH and IGH subsequently asserted that the Issuer's exercise was invalid. The Issuer intends to pursue this suit vigorously and believes that its claims are meritorious, however, there can be no assurance as to the ultimate outcome of this matter.
