As announced in November 2023, the Company successfully produced its first batch of ultra-thin lithium on metalized polymer anodes, a second-

generation lithium metal anode technology. At Li-Metal's advanced anode pilot plant in Rochester, New York, the Company has demonstrated its ability to leverage its roll-to-roll physical vapour depiction (PVD) anode technology and PVD equipment to produce its second-generation products at pilot scale.

In December the Company continued to make progress with this initiative.

B. Scale-up our modular metal production and scrap reprocessing process As announced in November 2023 the Company has successfully produced and shipped its first batch of lithium metal ingots.

The lithium metal ingots were produced at Li-Metal's recently commissioned lithium metal reprocessing and casting facility in Markham, Ontario.

In December the Company continued to make progress with this initiative.
