 - i. to approve the removal of MNP LLP (the "Former Auditor"), as auditor of the Company; and

- ii. to engage and appoint AGT Partners LLP (the "Successor Auditor"), as auditor of the Company, effective January 3, 2023.
- On January 16, 2023 the issuer announced that, further to its previous press releases of May 9, 2022, June 23, 2022, August 2, 2022, August 26, 2022, September 21, 2022, October 21, 2022, November 3, 2022 and December 6, 2022, the Company filed a revocation application on December 14, 2022 to revoke the failure to file cease trade order ("CTO") issued by the Ontario Securities Commission ("OSC") against the Company dated May 6, 2022. The CTO orders that general trading, whether direct or indirect, of the securities of the Company cease. A copy of the CTO has been posted to the OSC website. In connection with the Company's revocation application, the Company received a Comment Letter from the OSC on January 10, 2023 responded to the letter on January 18, 2023. The Company will provide further updates as they become available.
- In addition, the Issuer announced the resignation of Kristoffer P. Guajala as the Chief Operating Officer of the Company effective August 29, 2022.
- In addition, on December 6, 2022 the Issuer announced the resignation of Mr. Rob Suttie as the Company's Chief Financial Officer.
- In a press release dated December 12, 2022 the issuer announced that, further to its press release dated December 6, 2022, Mr. Vitali Savitski has been appointed as Chief Financial Officer effective immediately.
