The Issuer also owns and operates rapidly growing national chain of retail cannabis stores called Rise and, in the Las Vegas, Nevada area, a chain of stores called Essence, which both sell the Issuer's and third-party products. Headquartered in Chicago, Illinois, the Issuer has 13 manufacturing facilities, licenses for 96 retail locations and operations across 12 U.S. markets. Established in 2014, the Issuer employs over 1,700 people and serves thousands of patients and customers each year.
