Versus Systems Inc. (formerly Opal Energy Corp.) (CSE: OPA) is based out of Vancouver, British Columbia. During July 2018 the Issuer partnered with Moovly Media Inc., a cloud-based multimedia platform, offering Moovly Pro Memberships to gamers through Versus' WINFINITE platform inside NASCAR Heat Mobile. The Issuer also partnered with GameCake, a LA-based game developer and Comcast portfolio company, which will integrate Versus' WINFINITE platform with Emoji Charades to bring real-world prizing into millions of homes. Management focused on the development of WINFINITE and the Versus software products and continued to review and evaluate potential partners and opportunities.

Moovly enables anyone to create engaging multimedia content by making video creation affordable, intuitive and simple. Moovly users can choose from extensive content libraries in various styles as well as adding their own images, movies and sounds to create videos and presentations. Finished work can be published on corporate websites, Facebook and YouTube, and can be shared for viewing or editing in the on-line Moovly user gallery or downloaded with the click of a button. Moovly is used by creators and broadcasters in many arenas from personal YouTube channels, to gaming, to education, to non-profit organizations. With Moovly, content becomes easy to edit and fast to update. It is the choice for easy, cloud-based video creation and editing.

The Issuer also entered into a partnership with GameCake, a Los Angeles-based game developer and Comcast portfolio company. GameCake brings friends and families together with games for the devices they already own: streaming media players, smart TVs and smart cable boxes. The studio's first title, Emoji Charades, has already garnered multiple "game of the day" placements on the app store worldwide. GameCake will integrate Versus's Winfinite platform with Emoji Charades to bring real-world prizing into millions of homes. Emoji Charades puts one player in the hot seat, using their phone to describe trivia to players around them using nothing but emoji. Everyone else uses their collective brainpower to guess the phrase as fast as they can. Emoji Charades is available now for iOS and Apple TV.
