On June 6, 2018 the Company's wholly-owned subsidiary, Bliss Co Holdings Ltd. ("BlissCo"), submitted a licensed amendment application to Health Canada for the addition of bottled cannabis oil production.

In June Bliss Co Holdings Ltd. received a response back from Health Canada with four questions in June regarding our licensed amendment application for the addition of bottled cannabis oil production. BlissCo replied promptly with a response to Health Canada.

On June 20, 2018 BlissCo announced the appointment of Dr. Bryn Hyndman to our Advisory Board.

On June 21, 2018 BlissCo announced an LOI to distribute 720 kilos of medical cannabis to German through its German distribution partners.

On June 25, 2018 BlissCo announced that it has received a supply of premium dried cannabis from The Supreme Cannabis Company Inc.

On June 29, 2018 BlissCo announced its First Quarter Financial Results.

In June management was overseeing the ongoing production at its facility and purchasing the equipment for our cannabis oil extraction lab which is scheduled to be operational in early August.

The Company continued to make updates to its facility in advance of its Good Manufacturing Practices GMP facility audit in July for the purpose of earning EU-GMP.

The Company onboarded an additional QAP team member with a pharmaceutical background and finalized the hire of an Office Manager and Call Centre Manager whom has a background working in a medical clinic leading a team of nine.
