In late 2019 the Issuer obtained the official full license for cannabis research and development from the Portuguese National Authority of Medicines and Health Products (INFARMED). This license now allows the Issuer to research and refine cannabinoids and cannabis by-products inside Portugal / Europe, as well as to operate the existing R&D facility. Operations at the licensed facility were suspended on March 12th due to the emerging health regulations imposed by the Portuguese government as part of the measures taken to limit the effects of COVID 19. Operations at the R&D facility were still on hold for the month of May.

 - Management is finalizing active discussions with third party potential sources and growers of cannabis, hemp biomass and extract, within Portugal and also outside Europe, that will be used to fill resource requirements for the industrial facility.
 - Laboratory employees were working from home until the end of the month of March and during April and May was on the lay-off scheme with employment contracts suspended, hopefully to return on the 1st of June.

Management of the Issuer's Portugal operations took steps late in March 2020 to utilize the assistance on offer from the Portuguese government to assist with paying a percentage of employee wages during this period of enforced inactivity and inability to operate our R&D facility due to the disruptions caused by COVID 19. In Portugal this is structured as a technical simplified lay-off procedure. The Issuer anticipates these lay-offs will last as long as the virus-related restrictions are imposed.
