related products. The Company announced the launch of a new brand, Goodies, and formulations geared towards cannabis infused edibles that will be utilized by the License Holder. Additionally, the Company signed an agreement with Schilling Hard Cider to create proprietary formulations, brand, and distribution strategies for cannabis infused beverages.
