On February 1, 2022, the Issuer announced that Sportsflare, a wholly-owned division of the Issuer, has signed a partnership with BOA Solutions Ltd. ("BOA Gaming"), a provider of B2B sportsbook solutions based in Malta.

This partnership enables the Issuer to enter new gambling markets across different overseas jurisdictions and gain access to a wider audience of esports bettors.

On February 14, 2022, the Issuer announced that Sportsflare, a wholly-owned division of the Issuer, has signed a partnership with Skirmish Limited ("Skrmiish"), an app-driven community gaming platform based in the Isle of Man.

Through this partnership, Skrmiish will integrate Sportsflare's Bet-on-Yourself infrastructure into their platform to offer player-vs-environment skill-based gaming to their users. The collaboration begins with a rollout for Fortnite and Skrmiish plans to deploy Sportsflare's technology offering on more immensely popular esports titles in the future.

On February 28, 2022, the Issuer filed the audited annual financial statements and MD&A for Tiidal Gaming Holdings Inc. for the year ended October 31, 2021.
