The Issuer is a leading US science-focused, multi-state cannabis company. The Issuer's physician-led team of more than 400 employees provides best-in-class cannabis products and customer experience. The Issuer cultivates

cannabis in environmentally-friendly greenhouses, manufactures pharmaceutical-grade cannabis extracts, and sells its products at both company-owned and third-party dispensaries. Headquartered in Minneapolis, Minnesota, the Issuer currently has active operations seven states and holds licenses in one additional state and the Commonwealth of Puerto Rico.

The Issuer's management team focused on developing licensed facilities, reducing costs, raising capital, and improving operations.

On October 1, 2020 the Issuer entered into a definitive agreement with a subsidiary of Ayr Strategies, Inc. to sell certain assets and liabilities of its affiliated company, Ohio Medical Solutions, Inc. ("OMS"), for total consideration of US\$4.85 million. OMS holds a permit for the processing of medical cannabis in the state of Ohio. Based in Akron, Ohio, OMS manufactures cannabis-based products in a leased 11,300 square foot

processing facility. The transaction's total consideration of US\$4.85 million includes US\$1.15 million in cash and US\$3.7 million in the form of Right of Use liabilities associated with lease obligations. The transaction is subject to regulatory approval.
