  - **Following its policy of prudent financial management, the Corporation repurchased a final promissory note (\$242,036 owing to a shareholder) in exchange for the issuance of equivalent value of 4,840,720 shares (issued at \$0.05 per share) and 1,000,000 warrants (expiring in 12 months, exercisable at \$0.10 per share). The debt swap transaction leaves the Corporation with no debt outstanding.**
  - **The Corporation participated in the Power Africa Summit, an annual gathering of private sector, government sector and investment professionals, held this year in Miami, Florida.**
  - **The Corporation participated in investor meetings at PDAC in Toronto.**
