Report on Business

During the month of September 2019, the Issuer completed the following milestones, through Opco (defined below):

Opco has finished harvesting and processing of 2019 harvest yield. Due to not receiving funds to purchase agricultural machinery & processing equipment it is evaluated that more than a half of the planned season yield couldn’t be obtained.

Harvest of 35 hectares was finished in the end of September, and lack of funds resulted in absence of workforce and processing machinery. Hemp was harvested, dried and processed in the same day, with separation turning it into material ready for extraction and hemp seed. From 79 tons of fresh hemp, after drying and selecting, total 14,2 tons of leaf/flower ready for extraction and 3,3 tons of seed has been stocked. Together with already ordered 72 tons of processed hemp from Croatia, the remaining of old hemp after sale of 97 tons, and the new hemp from harvest 2019, In its inventory Opco has 93,2 tons of dried hemp ready for extraction.

In September 2019, the Company continued to explore potential partnerships. The two offers from month of August (TO from AgraFlora / JV with Abrazen-Devolli) are still being evaluated by the board members, as well as joint venture opportunity with Galafarm Skopje and Hanf Pharma Skopje.
