During the month of May the Company continued the ramp up of production at its pilot e-waste processing facility (EnviroCircuit). The Company continues to gain valuable knowledge from operating the facility while generating revenues from processing. During the month, the Company continued efforts to grow its E-waste supply chain.

The Company continues to pursue and develop commercial relationships in the primary and secondary metals sectors for its patented metal recovery technology. In the primary metals sector, the Company is focussed on opportunities for the recovery of gold from concentrates and ores. In the secondary metals sector, the focus is the recovery of gold and other metals from E-waste.

Business Impacts - COVID

The COVID-19 pandemic has had a devastating effect on the E-waste recycling sector. The global E-waste supply chain has been severely disrupted due to decreased access to supply and logistics challenges. This global disruption impacted EnviroLeach's operations, notably the previously announced staged production rate increase to full plant capacity.

In response to this unprecedented operating environment, EnviroLeach is working to expand its supply chain with marketing initiatives targeting domestic and international recyclers. Operations resumed at the Vancouver plant in February 2021 and the Company anticipates to continue to process E-waste over the coming months.
