The Company continues to focus on execution of its business strategy to provide proprietary oral thin film delivery technologies designed to improve patient outcomes.

The Company closed on \$1,100,000 in a first tranche of its previously announced equity private placement financing (the "Financing") which contemplated up to \$7,000,000 of gross proceeds, consisting of up to 41,176,470 units (the "Units") at a price of \$0.17 per Unit. On February 16, 2024 the first tranche of the Financing closed with 6,470,588 Units purchased; and accordingly, the Company issued 6,470,588 Common Shares and 6,470,588 Warrants. On February 23, 2024 the second tranche of the Financing closed. A total of 1,176,470 Units were purchased and accordingly, the Company issued a further 1,176,470 Common Shares and 1,176,470 Warrants.
