It operates in over 15 countries and generates multi-billion-dollar annual revenues. The technical evaluation project is focused on assessing the potential of Hydrochemolytic™ Technology (HCT) for recycling the Client's plastic waste from food packaging, and ii) announced the onboarding of a leading, multinational building materials company ("MBM Company" or the "Client") to its Customer Engagement Program (CEP).
