On September 4, 2019, the Company announced the installation of its QuickStrip™ production equipment at Chemesis International Inc. pursuant to the terms of the Managed Strip Services Agreement signed in October 2018 granting Chemesis the right to manufacture, distribute and sell RDT's QuickStrip™ cannabis products in the US Territory of Puerto Rico.

On September 4, 2019, the Company also announced the granting of 1,100,000 options to an officer and employees of the Company to purchase common shares at a price of \$0.82 any time up to July 29, 2024.

On September 11, 2019, the Company announced the installation of its QuickStrip™ production equipment at Aphria Inc. pursuant to the terms of the Managed Strip Services Agreement signed in November 2018 granting Aphria the exclusive right to manufacture, distribute and sell RDT's QuickStrip™ products to the medical and adult-use markets in Canada.

On September 12, 2019, the Company announced the results of a research study conducted by the University of Nevada Las Vegas were published in the scientific journal *Frontiers in Pharmacology* on September 10th.

The Company continues to focus on execution of its business strategy to provide proprietary drug delivery technologies designed to improve patient outcomes.
