Prior to the transaction, Benefits US, LLC and Harmony Products, LLC were engaged in the business of production, distribution, and/or retail sale of hemp and CBD-infused products, including topical analgesics, beauty, health and wellness products, under the name “Harmony Hemp”. Harmony Hemp, established in 2017 and based in Salt Lake City, is a leading brand in CBD infused personal care products with national distribution to more than 4,000 locations in major grocery and drugstores.**
