("Opticann"), a recently acquired subsidiary of the Issuer. The agreement between Opticann and Geocann provides Opticann exclusive distribution rights to brand and market a select portfolio of VESIsorb® formulated oral and topical CBD and CBG products to major U.S. retailers that dominate the U.S. food, drug, and mass retailer market, including CVS, Walgreens, Rite-Aid, and Walmart, among others.

## Appendix A

### PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9
