On December 31, 2019, Harvest issued a convertible promissory note for which an initial Form 9 was filed. Due to an inadvertent misinterpretation of the contractual language at the time of issuance, the conversion price in the Form 9 was based on a 20-day VWAP that was inclusive of the date of issuance. Pursuant to the convertible promissory note, the conversion price should have been exclusive of the issuance date. As a result, the correct conversion price should have been reported as CAD\$3.62276, rather than the previously disclosed conversion price of CAD\$3.6692. This amendment to the previous Forms 9 is intended to correct this pricing error.

PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9

The Canadian Securities Exchange and its subsidiaries, affiliates, regulators and agents (collectively, "CSE or the "Exchange") collect and use the information (which may include personal or other information) which has been provided in Form 9 for the following purposes:

- To conduct enforcement proceedings;
- To ensure compliance with Exchange Requirements and applicable securities legislation; and
- To fulfil the Exchange's obligation to regulate its marketplace.

The CSE also collects information, including personal information, from other sources, including but not limited to securities regulatory authorities, law enforcement and self-regulatory authorities, regulation service providers and their subsidiaries, affiliates, regulators and agents. The Exchange may disclose personal information to these entities or otherwise as provided by law and they may use it for their own investigations.

The Exchange may use third parties to process information or provide other administrative services. Any third party will be obliged to adhere to the security and confidentiality provisions set out in this policy.

All personal information provided to or collected by or on behalf of The Exchange and that is retained by The Exchange is kept in a secure environment. Only those employees who need to know the information for the purposes listed above are permitted access to the information or any summary thereof. Employees are instructed to keep the information confidential at all times.

Information about you that is retained by the Exchange and that you have identified as inaccurate or obsolete will be corrected or removed.
