The Acquisition was completed pursuant to the terms of a definitive agreement (the "**Acquisition Agreement**") dated June 10, 2021 between the Issuer and Happy Caps' two founders, Chief Executive Officer, Andrew Kobayashi and Chief Marketing Officer, Andrew Hatfield (collectively, the "**Vendors**").

The purchase price was comprised of \$50,000 cash and 1,290,323 Common Shares, with each Common Share priced at \$0.31. The Acquisition Agreement provides for up to \$550,000 of earn out payments to be made to the Vendors subject to reaching certain sales milestones, with all milestones subject to minimum gross margin requirements.

In addition to the foregoing, as per the terms of the Acquisition Agreement, the Vendors granted the Issuer an option to acquire all the remaining shares in Happy Caps not held by the Issuer, thus allowing the Issuer to become the sole shareholder of Happy Caps (the "**Call Option**"), at a 100% enterprise value equal to \$2,500,000. The Call Option will be exercisable at any time following a period of two (2) years from closing.

Appendix A

PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9

The Canadian Securities Exchange and its subsidiaries, affiliates, regulators and agents (collectively, “CSE or the “Exchange”) collect and use the information (which may include personal or other information) which has been provided in Form 9 for the following purposes:

- To determine whether an individual is suitable to be associated with a Listed Issuer;
- To determine whether an issuer is suitable for listing;
- To determine whether allowing an issuer to be listed or allowing an individual to be associated with a Listed Issuer could give rise to investor protection concerns or could bring the Exchange into disrepute;
- To conduct enforcement proceedings;

- To fulfil the Exchange’s obligation to regulate its marketplace.
