The Issuer is indebted to 1229741 BC Ltd. Inc. (the “Creditor”), a company owned by a director of the Issuer, in the amount of \$78,750 pursuant to a consulting agreement dated July 1, 2020 (the “Consulting Agreement”). The Creditor has agreed to accept the re-payment of the debt to be in the form of common shares in the capital of the Issuer (“Shares”). In order to preserve its cash, the Issuer has agreed to payment by issuing an aggregate of 1,125,000 Shares to the Creditor at a deemed price of \$0.07 per Share.

The Shares are being issued pursuant to the exemption found in section 2.14 of National Instrument 45-106 and are subject to a four month and one day hold period pursuant to applicable securities laws.

PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9
