Silver Sands Resources Corp. ("Silver Sands" or the "Issuer") and Mirasol Resources Ltd. ("Mirasol") and together with the Issuer, the "Parties") have agreed to an option in order for Silver Sands to acquire a 100% interest (the "Option") in Mirasol's 73,411 hectare Virginia silver project located in the Santa Cruz Province of Argentina (the "Project") pursuant to a Definitive Agreement with a term of 3 years (the "Definitive Agreement"). Until the time that the Option is exercised in full by Silver Sands, Mirasol shall operate the Project, however, Silver Sands shall pay the costs of maintaining the Project as part of its obligation to incur certain expenditures described below.

## Appendix A

### PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9

The Canadian Securities Exchange and its subsidiaries, affiliates, regulators and agents (collectively, “CSE or the “Exchange”) collect and use the information (which may include personal or other information) which has been provided in Form 9 for the following purposes:
