The Vendor will retain a 1.5% NSR Royalty on the Property. The Issuer will have the right to purchase 0.25% of the royalty for \$250,000 any time prior to the commencement of commercial production.

Appendix A

PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9

The Canadian Securities Exchange and its subsidiaries, affiliates, regulators and agents (collectively, “CSE or the “Exchange”) collect and use the information (which may include personal or other information) which has been provided in Form 9 for the following purposes:

- To determine whether an individual is suitable to be associated with a Listed Issuer;

- To determine whether allowing an issuer to be listed or allowing an individual to be associated with a Listed Issuer could give rise to investor protection concerns or could bring the Exchange into disrepute;
- To conduct enforcement proceedings;

- To fulfil the Exchange’s obligation to regulate its marketplace.
