And TGER Pty Ltd., owners of certain mineral concessions located in the Czech Republic and Germany, which closed on October 23, 2018. The properties are comprised of two concessions and four concession application parcels comprising 15,929 ha in both Germany and The Czech Republic. The concessions are less than 150 km from several electric vehicle battery plants, including BMW's principal supplier's planned factory at Erfurt.

The disclosure should be sufficiently complete to enable a reader to appreciate the significance of the acquisition without reference to any other material: The Issuer entered into a share purchase agreement to purchase 100% of the common shares of Tisová and TGER, non-related parties. On the closing date, an aggregate of 1.5 million common shares were issued to the original shareholders of Tisová and TGER (the "Vendors") (See Form 9 dated October 25, 2018 for further details). On July 1, 2019, the Issuer achieved the minimum expenditure requirement and issued an additional 2.5 million common shares to the Vendors, pursuant to the terms of the agreements (see Form 9 dated July 2, 2019 for further details). The Issuer still had an obligation to incur an aggregate \$3 million in exploration expenditures on the properties over a three-year period ending July 1, 2022, and issue an aggregate of 4 million common shares of the Issuer to the Vendors. The Issuer and the Vendors have agreed to amend the terms of both the Tisová and TGER agreements, such that the Issuer will immediately issue 3 million common shares to the Vendors in exchange for 100% ownership of both Tisová and TGER, and shall have no further obligations to the Vendors under the agreements. Pursuant to the amendment, it was agreed that 1/3 of the common shares being issued to the Vendors will be restricted from trading until August 1, 2021, 1/3 of the common shares issued will be restricted from trading until November 1, 2021, and 1/3 of the common shares issued will be restricted from trading until February 1, 2022.

## Appendix A

### PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9

The Canadian Securities Exchange and its subsidiaries, affiliates, regulators and agents (collectively, “CSE or the “Exchange”) collect and use the information (which may include personal or other information) which has been provided in Form 9 for the following purposes:

- To determine whether an individual is suitable to be associated with a Listed Issuer;
- To determine whether an issuer is suitable for listing;
- To determine whether allowing an issuer to be listed or allowing an individual to be associated with a Listed Issuer could give rise to investor protection concerns or could bring the Exchange into disrepute;
- To conduct enforcement proceedings;
- To ensure compliance with Exchange Requirements and applicable securities legislation; and
- To fulfil the Exchange’s obligation to regulate its marketplace.
