The acquisition is pursuant to a business sale agreement dated March 1, 2021 between EMMAC Life Sciences Limited, EMMAC Suisse Sarl, Rokshaw Limited (collectively, the “Sellers”), the Issuer and the Issuer’s wholly-owned subsidiary, Yooma Europe Limited. The acquisition of the “Blossom” and “MYO Nutrition Products” businesses is an asset purchase transaction, while the acquisition of the “Green Leaf” business is a share purchase transaction. The Issuer and the Sellers are not considered related parties for the purposes of applicable securities laws, however, certain directors of the Issuer are also directors, officers or shareholders owning more than 0.5% of one or more of the Sellers.

## Appendix A

### PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9

The Canadian Securities Exchange and its subsidiaries, affiliates, regulators and agents (collectively, “CSE or the “Exchange”) collect and use the information (which may include personal or other information) which has been provided in Form 9 for the following purposes:
