June 26, 2020, the Issuer announced that Enderby Entertainment will partner with Draganfly's Safe Set Solutions to resume film production post COVID-19 lockdown

June 18, 2020, the Issuer announced, former General Counsel of U.S. Department of Homeland Security and Raytheon Senior Executive, John M. Mitnick, was elected to Board of Directors of Draganfly

June 11, 2020, the Issuer announced that Draganfly Innovations and MicaSense Partner on Agricultural Package for Top Tier Imaging and Data Integrity

June 4, 2020, the Issuer announced the launching of its global dealer network for sales and service of Draganfly technology solutions including its secure, North American made drones.

Management has been busy with various corporate development opportunities including discussing the integration of a health monitoring technology onto the company's drone platform. The Issuer held its Annual General Meeting on June 18, 2020. A copy of the management information circular dated May 12, 2020 regarding the Annual General Meeting was filed on SEDAR on May 19, 2020.

As noted above, the Issuer announced the launch of the Draganflyer Commander Ag-Pro Package, especially designed for the agricultural industry. The Draganfly Commander Ag-Pro Package includes everything needed to perform crop health assessment, irrigation monitoring and yield optimization. Combining the MicaSense RedEdge-MX multispectral sensor and the Draganflyer Commander UAV, the Ag-Pro Package is ideal for projects requiring long flight times, a high level of data resolution and accuracy, and the utmost data security.
