The disclosure should be sufficiently complete to enable a reader to appreciate the significance of the transaction without reference to any other material: The Issuer has executed an agreement and plan of merger (the "Agreement") to acquire all of the interests in Ketamine Wellness Centers Arizona, LLC ("KWC"), which operates 10 ketamine infusion treatment clinics, across Arizona, Colorado, Florida, Illinois, Minnesota, Nevada, Texas, and Washington.

2. Provide details of the acquisition including the date, parties to and type of agreement (eg: sale, option, license etc.) and relationship to the Issuer. The disclosure should be sufficiently complete to enable a reader to appreciate the significance of the acquisition without reference to any other material: Issuer will acquire all of the membership interest of KWC through a reverse triangular merger between KWC and a newly organized wholly-owned subsidiary of Issuer (the "Transaction"). Subject to customary adjustment terms, Issuer has agreed to issue SV Shares ("Consideration Shares") to the members of KWC (the "Members"), having an aggregate value of US\$5,000,000 with the number of Consideration Shares to be issued determined based on a price per share equal to the ten trading day volume weighted average trading price ("VWAP") of the Consideration Shares on the Canadian Securities Exchange (the "Exchange") immediately prior to closing of the Transaction. Issuer will further pay to the Members an amount equal to US\$5,000,000 in cash (the "Cash Consideration") with US\$3,500,000 of such Cash Consideration to be paid on the closing date, US\$750,000 to be paid on the date that is 12 months after the closing date, and US\$750,000 on the date that is 24 months after the closing date. In addition, the Members will be eligible to receive additional Consideration Shares in an amount equal to US\$100,000 upon KWC opening up further clinics that each post three consecutive months of profitability and minimum revenue of US\$135,000 for a period of three consecutive months after opening (each a "New Clinic Milestone"). The Members may earn up to an aggregate cap of US\$3,000,000 in Consideration Shares pursuant to such new clinic milestones, based on a price per share equal to the 10 trading day VWAP of the Consideration Shares on the Exchange immediately prior to the date such milestone is achieved.

Such additional consideration to satisfied by Issuer's issuance of additional consideration shares at a price per share equal to the ten (10) trading day VWAP of the consideration shares on the Exchange on the trading day prior to the date the Milestone is reached . .
