EA1™ DUST SUPPRESSANT - FINALIST IN THE 2018 GREEN LATIN AMERICA AWARDS

(CSE: EAC) (“Earth Alive” or the “Company”), is pleased to announce that the Company’s EA1™ Dust Suppressant has been selected as a finalist in the 2018 edition of “Premios Latinoamérica Verde”, the Green Latin America Awards. Earth Alive’s EA1 is among the top 50 finalists in the Water and Responsible Consumption categories.

The Green Latin America Awards recognizes the 500 best social and environmental projects that are directly aligned with the country’s Millennium Development Goals. In 2016 Earth Alive’s organic biofertilizer Soil Activator was also a top 50 finalist in the Latin America Green Awards, and the Company is honored yet again with the nomination of its EA1™ Dust Suppressant from amongst thousands of contenders. This recognition is a testament to the efficacy and positive environmental impact of this state-of-the-art organic and biodegradable microbial dust suppressant.

The 2018 edition includes participants from 37 Latin American countries, as well as guest countries Spain, USA and Canada. A committee of 146 experts from the environmental, engineering, economic sciences and marketing sectors evaluated the environmental initiatives and selected the 500 most innovative projects in ten categories. EA1™ Dust Suppressant was recognized as one of the top 50 projects in the Water Category, which evaluates projects related to fresh water and its sustainability, community access and recovery. It was also ranked among the top 50 in the Responsible Consumption Category, which highlights initiatives that involve sustainable processes and positively impact production, corporate responsibility and environmentally friendly materials. This year Earth Alive is the only Canadian company to be recognized by the Latin American Green Awards.
