The Issuer continues to reach a number of important milestones on its path forward, as an integrated healthcare company - serving patients through medical centers, telemedicine platforms, a medical device company, and a high complexity medical diagnostics laboratory.

The Issuer continues to focus on its national clinic expansion strategy. On November 1, 2021 the Issuer has announced the opening of its next The Medi-Collective ("TMC") clinic in Mississauga, Ontario.

The management remains committed to entirely focusing its corporate priorities and expenditures on its integrated healthcare business.

On November 22, 2021 the Issuer has filed its condensed interim consolidated financial statements and related management's discussion and analysis for the three months ended September 30, 2021 and 2020.

The Issuer's subsidiary Kai Medical Laboratory has received approval to be a COVID-19 Pandemic Provider able to administer COVID-19 vaccinations in the U.S. On November 8, 2021 Kai Labs commenced its first COVID-19 vaccine drive-through service in Dallas, Texas and is leveraging its CARES Act funding status to generate new revenues offering vaccination services in the State of Texas.

The Issuer's subsidiary MediSure has launched the MediSure Advantage subscription plan option for patients as part of its Diabetes Awareness Month initiatives.

The MediSure Advantage subscription plan will connect customers with flexible shipment options for the products they need most at the pace that works best for them. Individual users can sign up to receive their products monthly, quarterly or semi-annually. The subscription plan includes a blood glucose monitoring system (single-user or multi-user for clinical settings) and test strips. In addition to customizing the order frequency, users may customize the number of test strips per order. They will be available in intervals of one hundred up to four hundred.

Beyond the convenience of automated orders, the MediSure Advantage plan provides individuals with other bonuses such as free shipping on all orders, free battery replacements, alcohol wipes and lancets. Advantage holders will also have access to a dedicated customer service agent for priority troubleshooting. Through its "I AM COVERED" program, MediSure offers direct billing with insurance companies and government formularies in most provinces and territories.

The Issuer continues to respond to a review requested by Health Canada. The review is focused on assigning the most appropriate medical device class for Kai Care Test. The Issuer has temporarily ceased distribution of Kai Care At Home Saliva based COVID-19 RT-PCR Test Kits in Canada until the Health Canada review can be completed.
