On May 14, 2021 the Issuer closed a non-brokered private placement raising \$8,000,000 from Eric Sprott (\$4mm) and New Found Gold (NFG) (\$4mm). The Company issued 13,333,334 units at a price of \$0.60 per unit. Each unit consists of one common share and one warrant exercisable at \$0.70 for a term of 24

months expiring May 24, 2023. The securities are subject to a four month hold period expiring September 15, 2011.

On May 25, 2021 the Issuer granted to certain directors, officers, employees and consultants an aggregate of 1,775,000 incentive stock options at a price of \$1.33 expiring May 25, 2023.

The Company has received diamond drilling permits for 12 holes, approximately 3,000 meters at the Jonathan's Pond prospect. Exploits has also announced drilling has started at the Schooner North prospect in the Mt. Peyton project.

In addition, the company's targeted marketing campaign to increase investor awareness continues.
