The Company's business focus remains on precious and base metal exploration for resource development in eastern Canada.

As reported previously, the Company announced a proposed business combination (Transaction) whereby Mountain Lake would acquire certain assets and complete a

spin-out of its mining properties to its existing shareholders (the “Spin Out”). Both the Transaction and Spin Out are proceeding and nearing completion. Notification of a Special Shareholder Meeting will be disseminated in the very near future.

The Company’s exploration has been directed at its flagship Newfoundland mineral properties at Caledonia Brook gold project. The Company is also re-evaluating recently discovered high-grade gold from grab samples near its Little River (gold-antimony) property. MLK continues to compile assessment data several mineral occurrences in Newfoundland. The Company is currently making 2019 exploration plans for its Highfield Zn-Pb project in Nova Scotia.

Management continues its focus on matters related to the completion of its announced Transaction and Spin Out, and evaluation of potential new mineral property acquisitions in Eastern Canada. The Company anticipates a resumption in trading at the end of July 2019 following shareholder approval of its business agreement.
