The Company's business focus remains on precious metal exploration for resource development in eastern Canada.

Management was focused on moving closer to completion of its announced acquisition and private placement financing associated with this transaction.

The Company primary geological objectives were directed on financing and exploration plans at its three Newfoundland mineral properties, namely Caledonia Brook (gold), Little River (gold, antimony), and Glover Island (gold, base metal). The Company continues its review of mineral properties in New Brunswick, Newfoundland, Nova Scotia for possible acquisition.

2. Provide a general overview and discussion of the activities of management. **Management continues its focus on completion of its acquisition, financing, and examination of potential new mineral property acquisitions in Eastern Canada.**

The Company is progressing on schedule with regulatory and legal requirements related to its June 6, 2018 transactions with 1151024 B.C. Ltd. (“1151024”) and 1157630 B.C. Ltd. (“1157630). The Company anticipates a resumption in trading in late August or early September following shareholder approval of the agreement. The Company also completed its announced share consolidation for 10 old shares for 1 new share. The total number of outstanding shares in Mountain Lake Minerals is now 8,020,297.
