On November 18, 2016 the Issuer closed a financing (the "Financing") wherein the Issuer announced that it had raised a total of \$231,000 through the sale of 4,620,000 units at \$0.05 per Unit (the "Units") where each Unit consists of one common share (each a "Share") and one half of one common share purchase warrant (the "Warrants"). Each whole Warrant will entitle the holder to acquire one additional Common Share at an exercise price of \$0.10 for a period of 24 months from closing of the Financing, provided that, in the event the closing price of the outstanding Common Shares on the Canadian Securities Exchange (the "CSE") is greater than \$0.15 for a period of 10 consecutive trading days at any time following the closing of the Financing, the Company may, at its option accelerate the expiry date of the Warrants by giving written notice to the holders of the Warrants and in such case the Warrants will expire on the earlier of: (i) the 30th day after the date on which such notice is given by the Company; and (ii) 24 months from the closing of the Financing.
