Effective March 16, 2026, the Issuer entered into a Sales Deployment and Consulting Agreement (the "**Agreement**") with Abdul Salih (the "**Consultant**"), an arm's length third-party. The Agreement is for the period commencing as of February 1, 2026, and ending on May 30, 2026. The Issuer will pay the Consultant a consulting fee of \$22,000.00 for the term of the Agreement. The Consultant will provide services including building, launching, and operationalizing the Issuer's sales engine for EMTWerx. These services will support the complete sales deployment cycle.
